As per the Regulations notified by the Council vide F. No. F.No. 37-3/Legal/2004 dated 14th Sept 2006 and norms, standards, procedures, and conditions prescribed by the Council from time to time and based on the recommendations of the Expert Committee and EC Sub Committee, I am directed to convey the approval of the Council to KAMALA EDUCATION SOCIETY for establishment of new MBA Institution in the name and style of PRATIBHA INSTITUTE OF BUSINESS MANAGEMENT (PIBM), Block No.D-III, Plot No 3, MIDC, Chinchwad, Pune-411019, MAHARASHTRA for conduct of the following courses and intake.

Note: - The Letter of Approval (LOA) shall be valid for two years from the date of issue of letter of approval for obtaining affiliation with concerned University and fulfilling State Government requirements of admission.

The PRATIBHA INSTITUTE OF BUSINESS MANAGEMENT (PIBM), Block No.D-III, Plot No 3, MIDC, Chinchwad, Pune-411019, MAHARASHTRA shall obtain necessary affiliation/ permission from the concerned affiliating University as per the prescribed schedule of the University/ Admission Authority etc. The Applicant Society/Trust/Institution shall send information about commencement of the above courses to AICTE. Incase the institution could not commence the above mentioned courses for whatsoever reasons during the two years period from the date of issue of this letter, the approval becomes invalid and the applicant society/trust shall have to make fresh application to AICTE for grant of fresh approval.

The approval is further subject to fulfillment of following conditions.

1. That the management shall provide adequate funds for development of land and building and for providing related infrastructural, instructional and other facilities as per Council's norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
2. (a) That the admissions shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.
(b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
(c) That the admissions to the courses shall be made only after the affiliating University /State Board has given permission to start the course.
(d) That the Institution shall not allow closure of the Institution or discontinuation of the course(s) or start any new course (s) or alter intake capacity of seats without the prior approval of the Council.

This is in continuation to the Council's earlier letter, the revised status of the programme of the Institute, as follows:

Note: The approval for increase in intake / additional course(s) / variation in intake is valid for two years from the date of issue of this letter for obtaining affiliation with concerned University and fulfilling concerned State Govt. requirements for admission.

- The institution is required to submit a joint FDR of Rs. 15 lakhs for the above sanctioned additional course of MCA by 15th October 2009 to the concerned Regional Office.

"That the institution shall take appropriate measures for prevention of ragging any form, In the light of direction of Supreme Court of India in Writ Petition No. (C) 656/1998. In case of failure to prevent the instances of ragging by the institutions, the council shall take appropriate action including withdrawal of approval."

The additional intake is being granted based on the projection shown in the Detailed Project Report regarding additional built-up space, faculty and other facilities for the proposed intake. It may be noted that all facilities including additional built up area should be made available before the commencement of the next academic session. Random surprise inspection would be carried out to verify facilities and if the institute is found deficient in fulfillment of norms & standards of AICTE, appropriate action would be initiated by the Council.


Please note that other terms & conditions mentioned in the earlier letter of ext of approval / Increase in intake / Grant of additional Course will remain same.

This approval is granted based on the Appraisal of the information by the institution on infrastructural faculty and academic facilities created for the proposed course(s). Therefore the approval is subject to the verification of the claims made by the institution through an Expert Committee visit. In case the claims made by the institution are found to be false, the approval granted shall be liable to be withdrawn.

If the above revised order is not in conformity with Courts direction (if any) it may be treated cancelled.

The aforesaid proposal for increase in intake / additional course(s) has been processed in accordance with MHRD Letter No.1-4/2009-TS-II dated 12.08.2009



11. That a Refundable Performance Guarantee Fee (RPGF) shall be deposited with AICTE, New Delhi for an amount and period prescribed by the Council from time to time.
12. AICTE may carry out random inspections round the year any time for verifying the status of the Institutions to ensure maintenance of norms and standards.
13. That the AICTE may also conduct inspections with or without notifying the dates to verify specific complaints of mis-representation, violation of norms and standards, mal-practices etc.
14. That the Institution by virtue of the approval given by Council shall not automatically become claimant to any grant-in-aid from the Central or State Government.
15. That the Management shall strictly follow further conditions as may be specified by the Council from time to time.
16. That the institution shall take appropriate measures for prevention of ragging in any form, in the light of directions of Supreme Court of India in Writ Petition No. (C) 656/1998. In case of failure to prevent the instances of ragging by the institutions, the Council shall take appropriate action including withdrawal of approval.
17. That in the event of a student / candidate withdrawing before the starting of the course, the wait listed candidates should be given admission against the vacant seat. The entire fee collected from the student, after a deduction of the processing fee of not more than Rs. 1000/- (Rupees One thousand only) shall be refunded and returned by the Institution / University to the student/candidate withdrawing from the programme. It would not be permissible for Institutions and Universities to retain the School/Institution Leaving Certificates in original to force retention of admitted students (See Public Notice AICTE/DPG/03(01)/2008)
18. In the event of non-compliance by of PRATIBHA INSTITUTE OF BUSINESS MANAGEMENT (PIBM), Block No.D-III, Plot No 3, MIDC, Chinchwad, Pune-411019, MAHARASHTRA with regard to guidelines, norms and conditions prescribed from time to time the Council shall be free to take measures for withdrawal of its approval or recognition, without consideration of any related issues and that all liabilities arising out of such withdrawal would solely be that of the concerned PRATIBHA INSTITUTE OF BUSINESS MANAGEMENT (PIBM), Block No.D-III, Plot No 3, MIDC, Chinchwad, Pune-411019, MAHARASHTRA.
